Collaborative Action Groups (CAG) updates

CAG 1 (Defining list of problematic plastic items): The <u>Ambition List document</u>, launched in February, identifies unnecessary or problematic plastic packaging items in the Indian context, along with an overview of the framework used to identify these items and details the next steps for the Pact and its signatories.

<u>Read</u> what CAG 1 Chair, Abhishek Sahay, has to say about the Pact and the items identified in the Ambition List.



CAG 2 (Designing plastic packaging to be 100% reusable, recyclable, or compostable): Although HDPE packaging is widely collected and recycled, the recyclate is often used for low-value applications (such as pipes, furniture, and flowerpots). The upcoming HDPE design guide provides an overview of design choices to improve its recyclability for high-value applications. Members were asked to give their inputs on the HDPE design guidance at the meeting held on 27th April.

CAG 3 (Increasing quantity of plastic packaging effectively recycled): Two showcase meetings of Sprint Group 1 were held in which different models of engagement with the informal waste sector were presented. At these meetings, four organizations presented their models: SWaCH Pune Seva Sahakari Sanstha Ltd., Stree Mukti Sanghatana, Waste Warriors, and ReCircle.

CAG 4 (25% average recycled content across all plastic packaging): At the meeting held on 13th April, members discussed the challenges in adding recycled content in films and flexibles, and a case study was presented by Lucro Plastecycle Pvt. Ltd.
