IPP publications

The Pact supports its signatories by providing reliable information on plastics in the Indian context through different publications.



EPR guidelines for businesses, have set out ambitious targets for plastics collection, sorting, and recycling in India. To achieve these targets, it is important to have credible information on the landscape of plastics recycling in India.

The [report](#) gives a deeper understanding of the plastics recycling sector in India, formed through first-hand interactions with over 600 recycling units. This understanding is critical to help stakeholders meet their EPR targets, improve plastic recovery rates in India, and meet the Pact's Targets for 2030.

Post consumer-use, HDPE containers are widely collected via formal and informal waste management channels and sent to recyclers. Although they are made of a single resin and readily recycled, closed-loop recycling for non-food contact HDPE bottles is not widely practiced in the



country. The [design guidance](#) provides an overview of the technical and design-related aspects that will encourage closed-loop recycling for non-food contact HDPE bottles.

In the Indian context flexible plastic packaging is one of the most challenging packaging formats to address in terms of collection, recycling, and incorporation of recycled content. Unlocking progress towards Target 4 of the Pact will require a better understanding of these challenges of adding recycled content in films and flexibles. This [document](#) identifies them and outlines the Pact's next steps to transition to a circular economy for flexible plastic packaging.



Informal waste sector

Despite the critical role of informal waste workers in India, they are often unrecognized and highly vulnerable. The [insights report](#) identifies the gaps in the existing waste management structure in India, and the challenges faced by informal workers. The recommendations in the report could help establish effective approaches to waste management utilizing existing infrastructure, and, integrating informal workers and self-sustaining enterprises into solutions.

In India, informal waste workers manage a significant bulk of the total plastic waste generated. Engaging with the informal waste sector will ensure secure livelihoods for informal waste workers, help stakeholders across the value chain achieve their EPR targets for collection, sorting, and recycling of plastic waste, improve plastic recovery rates in the country, and help the Pact's signatories meet the Targets for 2030.

Going circular with transparency and traceability

To achieve a circular economy for plastics packaging, transparency within the packaging supply chain is crucial. AVI Global Plast, addresses this need with AVI Trace, a proprietary traceability platform, offering batch-by-batch traceability through accountability

and transparency of actions across the waste value chain.

It captures the entire journey of plastic waste, from collection, recycling, and back into packaging, through on-pack QR codes. Consumers can scan these to find out when and where plastic waste was collected, sorted, recycled and converted into the packaging they are using.

With a digital dashboard to provide users with a range of services, AVI Trace allows monitoring of waste sources and tracks


- amount of recycled waste,
- fuel savings,
- carbon emission reductions,
- chain-of-custody documentation, and,
- certifications to support sustainability claims.

The platform could help stakeholders detect greenwashing, establish trust in consumers, and positively influence consumer behaviour.
