## Article Structure

For the sake of consistency, all articles to follow the structure given below:

- **Title:** Should not be more than 7-10 words
- **Abstract:** Should not be more than 300 words.
- **Introduction:** Include background, objective/ perceived outcome, what each section will include, and how you are planning to conclude.
- **Main body:** Current scenario; regulatory framework; identifying barriers; exploring opportunities and citing case studies & best practices.
- **Conclusion/Way forward:** Include your own thoughts and opinions, and a way forward where you could discuss the potential research work.
- **Reference & Citation:** In-text citing as well as the listing of all the references should be included in all write-ups. For detailed guidance, please go through [APA style guide](#).
