








Business Risks Associated with Waste Management

Brand risk is the possible damage to a brand's overall standing that derives from negative signals regarding the brand

Mismanagement of wastes resulting in environmental damage can lead to risks the brand image.



Financial risks involve financial loss to firms. In case planning is poor and waste management strategies are not implemented effectively then it leads to generation of waste that could have been avoided. This results in financial loss to the company.

Regulatory risk is the risk that a change in laws and regulations will materially impact a business. A change in laws or regulations made by the government or a regulatory body can increase the costs of operating a business, reduce the attractiveness of investment and/or change the competitive landscape.

Advantages of Zero Waste to Landfill Assessment cum Verification

Improved resource economy and efficiency

Zero waste to landfill requires redesigning of products that requires less material and fewer resources to process and manage. This leads to improved resource economy and increased efficiency.

Stronger brand identity
